Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of YAYASAN FOOD BANK MALAYSIA, which comprise the statement of financial position as at 31 December 2023, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the financial year then ended, and notes to the financial statements, including a summary of significant accounting policies, as set out on pages 10 to 30.
